## CONCEALED WEAPONS PERMIT APPLICATION INSTRUCTION SHEET

LEWIS & CLARK COUNTY RESIDENTS ONLY. WE DO NOT PROCESS OUT OF COUNTY APPLICANTS.

## Conditions to be met:

- 1. U. S. Citizen or Permanent lawful resident. Permanent residents must provide a Permanent Resident ID card. If you were born abroad we may require a Passport or a Consular Report of Birth Abroad.
- 2. 18 years or older.
- 3. Must have a valid Montana Driver's License or other picture I.D. issued by the State of Montana.
- 4. Must be a resident of the state of Montana for 6 months or more.
- 5. Must show proof of hunters safety education or approved firearms safety training course or DD214.

<u>Duplicate</u> Hunters Education Certificates can be printed from the MT Fish Wildlife and Parks website: <u>www.fwp.mt.gov</u>; more specifically: <u>http://fwp.mt.gov/education/hunter/born.html</u>

- 6. **Must properly fill out entire application** prior to your appointment and sign in Sheriff's presence or his designee. If you do not have a *completed* application prior to your appointment we may need to reschedule your appointment.
- 7. Application must be accompanied by \$50.00 (\$25.00 for non-expired renewal).
- 8. Must be fingerprinted at the DOJ. (New permits & permits over a year expired). Instructions on how to do this will be given to you at your appointment. **They charge \$5.00 for fingerprinting**.
- 9. **RENEWALS**: MCA 45-8-322(3) states in part: "The permit must be renewed for additional 4-year periods upon payment of a \$25 fee per renewal and upon request for renewal made within 90 days before expiration of the permit." **If the permit is expired it is \$50.00**.

PLEASE COMPLETE THE APPLICATION -- DO NOT SIGN OR DATE IT -- YOU WILL BE REQUIRED TO SIGN THE APPLICATION IN THE PRESENCE OF THE SHERIFF'S DESIGNEE.

CHECK, CASH OR MONEY ORDER PREFERRED. THERE IS AN EXTRA CHARGE FOR CREDIT/DEBIT CARDS.
