This month we have sent 4 people to treatment. We have assisted one person in enrolling with the VOA.

We did recreation this month with the local NA group and did Pipes For Hope. Where we went around the jail with Air horns letting those that are incarcerated know that they have a family and friends to come out to when they get out.

This month we lost two staff members. We were able to hire one more staff member and looking to hire another.

Moving forward until staff is hired we will have to be shut down on Saturdays. Hopefully just for two weeks.

We have done a lot of housing applications with people this month.

Not a whole lot to report this month. Groups have been going good, We were only able to do WRAP group one time this month as with a staffing shortage we need to change the day it is on so we have two facilitators as the group requires two. We will work out the Day change for October. Also we have had a lot of people that leave when we say it is time for group and we end up with just one person in group. Hoping this will change in the winter time as no one wants to be outside for an hour while we do group.

Pureview Medical Van came 9/30/2025 this has been great for our Peers. We are working on picking a different day for this as Tuesday mornings are shower days and so when they come we are very slow.

We asked that all peers please leave the property at 3pm. Staff will not leave the premises until all peers have left.

Introduced new staff Deb she will be working the front desk.

Talked about losing two staff and that we may have to be shutdown on Saturdays until further notice.

We spoke about the cruise avenue encampment going on and that people need to not be leaving stuff there all day. Its okay to sleep for the night but need to roll your stuff up and leave in the morning.

We also informed peers that Gods Love has decided they will not be opening their doors to everyone to sleep on the floor this winter. They will be adding 10 more beds in the back but you have to have a job to be able to stay there. We discussed how we would not be able to provide overnight shelter for many reason. Peers did not have to much to say on this. We did discuss maybe a few church options but volunteers would be needed and trained staff to deal with situations that may arise
