4. "More than Just a Jailer" - Sgt. Clair Swain

Sgt. Swain spoke to her recent op-ed in the Helena IR, including her experience as a Detention Center Officer and the current staffing issues at the Detention Center. The Detention Center supervises between 140-155 inmates daily and is currently short-staffed by 18 officers. Sgt Swain outlined issues with both recruitment and retention, discussed minimum qualifications for a Detention Center Officer, and requested assistance from the CAC to inform the community.

5. CAC Bylaws updates – Karen English and John Lytle

John and Karen reviewed the changes made to the by-laws, including:

- Reducing membership from twenty-five members to fifteen members.
- Increasing term-limits from two years up to ten years
- Increasing the time for individuals who are supervised by the Department of Corrections as a Probationer or Parolee to be eligible for membership from one year to two years
- Changing "Task Force/s" to "Work Groups and Subcommittees"

Moffie made a motion to approve the changes. Jen seconded. No discission, and the updates to the by-laws were unanimously approved.
