

# Citizens Advisory Committee Meeting April 21, 2023 - Noon Law & Justice Center Atrium

# 4. Tour of Hope Center Ministries – Carolyn Belling

## 5. CJS Updates – Kellie McBride

## 6. Non-Agenda Items

- Clair testified at a State committee meeting in support of a bill that expands
  workers' compensation coverage for Detention Center officers to the same level
  as Sheriff Deputies. The Detention Center continues to be at emergency staffing
  levels. Kellie noted that a large percentage of jail inmates are held pretrial, and
  releasing those inmates to pretrial services may help alleviate some of the
  pressure on Detention Center staff.
- The group discussed the housing shortage exacerbated by low wages, at a State level and especially in Lewis & Clark County.
- The group discussed the variability in treatment and transition options in the community.
  - John discussed how the pre-release center does not teach basic skills, such as how to do laundry, how to cook, etiquette, and other basic skills that the general population may take for granted.

- Carolyn elaborated on the skills taught to Hope Center residents. Many addicts already have the education about themselves and their addiction but don't know how to apply it in their daily lives, and therefore often fail in the transition from treatment to society.
- Jenn discussed the diversity in treatment philosophies. Hope Center and the YWCA may refer individuals seeking help to one another depending on the needs of the individual.
- Jenn asked for an update on the Journey Home. Kellie mentioned that Lewis and Clark County Public Health is in contract negotiations with Many Rivers Whole Health for the Journey Home, but details are unknown at this point.
