## 4. CJS Update - Kellie McBride

- **a.** Pretrial is fully staffed with officers. Keaton Welch is the newest officers.
- **b.** There is an opening for Pretrial Court Services Assistant. Zoe McBride is currently temping.
- **c.** CJS is still looking for a Data Analyst.
- **d.** AmeriCorps Vista application was accepted. Unknown if fully passed yet looks positive.
- e. New contract with Tyler Technology for Data and Case Management system.
- f. Open House for new CJS Office was on 6/20/2024.

# 6. NNCJCC Annual Meeting – CAC Panel Presentation – Tom Cordingley

- **a.** Kellie heard back from Aimee Wickman (Coordinator of NNCJCC). The highest rated presentation at the NNCJCC meeting was by the C.A.C.
- **b.** Takeaways from the NNCJCC—impressed with the confluence between departments (CJS, Judges, community).

## 7. Non-Agenda Items

- **a.** Brad Bragg: Detention Center is extremely short-staffed. Issue stems from the "shift work" nature of Detention staffing.
  - i. Detention Center is half-staffed but still full. Outside Detention officers are being pulled off duty to help in the DC.
  - ii. Karen English asked what a potential fix could be. Brad suggested that the DC will be rebuilt to hold more people with less staff. They are asking the voters to pay for the new DC around 2026.
  - **iii.** Kellie brings up that the community was promised fewer individuals in the jail. Many interred individuals can be diverted from the DC.
  - **iv.** Mike suggests more diversion techniques and a need for the public to understand diversion rather than incarceration.
