- a. Presentation Name LCC DES Autumn Ashdale, lessons learned from Maui
  - i. Doug Dodge (Jeff. Co. EM) went too and added his perspective.
  - ii. There were 4 fires in total that started at different time periods.
  - iii. A lot factors affected response including power lines being down and access issues.
  - iv. 100 fatalities as of now
  - v. Notifications were an issue during the incident with response agencies not communiticating.
  - vi. No singular definitive ICP with unified command. Many Silos.
  - vii. Autumn was deployed through EMAC which is a state to state mutual aid agreement.
  - viii. Autumn was a Planning Section Chief for an additional incident if it occurred during recovery.
  - ix. She spent a lot of time in documentation and getting data for response and organizing the EOC. There were a lot of changes with staff coming and going including leadership throughout here time there.
  - x. There was a lack of organization and direction overall within the EOC.
  - xi. She trained new short term staff to get them up to operational speed that didn't have experience in an EOC.
  - xii. Maui is consolidated county and is an island with limited resources and a lack of planning as well as trained personnel to fill EOC positions.

- xiii. Lack of overall resource availability was an issue as well as any assistance from mutual aid.
- xiv. Lessons learned:
  - 1. Lack of trained staff locally and at the state level.
  - 2. Lack of experience with larger incidents
  - 3. Emergency Operations Plan
  - 4. Trust/politics/supporting staff (A lot of Turnover)
  - 5. Lack of support from the government.
- xvi. Doug D. Lesson learned is the impact and importance of recovery
- xvii. "Response impacts recovery" they have not began to work on this to improve.
- xviii. There is fear about liability and being honest in the aftermath.
- xix. Each response agengy did their own after action review with no unified command created and illustrated a lack of continuity for response.
- xx. Kevin Horne What does opening an EOC in Helena look like?a. Explanation from Autumn, Doug, and Kyle
- xxi. Neal Murray stated that there is money out there for seismic protections through grants.
