- a. Presentation Name Kevin Horne, Jenny Chambers, Dan Karlin, L&C County Public Works
 - i. JC Public works is in basic emergency plan in many areas, transportation routes/access, debris management, etc.
 - ii. KH public works operations Roads, bridges, and signage is a big portion. Equipment in Lincoln, Augusta, and around the county. Has a limited amount of PPE and emergency equipment.

- iii. KH Have emergency power backup at public works to support fueling, communications, heating, etc.
- iv. KH Who has the authority to dispatch county assets? Flow chart in play. Commissioners, Sheriff and his designees, and chief operating official can stand up resources. Also connected to Malmstrom Air Force base as needed.
- v. KH Has a pager callout system for personnel in PW, and also has emergency call out phone numbers down the chain of command.
- vi. KH Wants to know what equipment is out and what it is doing. His staff is not emergency responders and only assists those who are.
- vii. WK Asks if equipment rotates around the county. Fleet is worth 13 million. Usually has graders, water trucks and other equipment staged in regular locations. Movement can be fluid around the county due to need.
- viii. Undersheriff mentioned importance of adding non-emergency responders to CISM when appropriate. Kyle suggests using dispatch to assure that all responders are invited to a CISM and not left out.

 - i. Was a field officer and mitigation coordinator with state DES
 - ii. Hiring his other person in his officer currently.
