<u>Labor Agreement Between Lewis and Clark County and the Montana Federation of Public</u> Employees. (Kari DesRosier)

[2:26] Kari DesRosier, Human Resources Director, presented a labor agreement with the Montana Federation of Public Employees representing the Road/Bridge/Shop employees of Public Works. The agreement period is July 1, 2025 through June 30, 2027. Staff recommends approval of the agreement.
