The Lewis and Clark Board of County Commissioners Public Meeting was held on Tuesday, August 26, 2025 at 9:00 AM in Commission Chambers, Rm 330.

Roll Call

A motion to Approve was made by Commissioner Rolfe and seconded by Commissioner Hunthausen. The motion Passed on a 3- 0 vote.

Bid Award. Courthouse Roof and Gutter Replacement Project. (Audra Zacherl)

[3:32] Audra Zacherl, Public Works Assistant Director, presented a bid award for the Courthouse Roof and Gutter Replacement Project to the low bidder, Summit Roofing of Missoula Montana for an amount of \$368,815. Staff recommends approval of the bid award.

No public comment was received.

A motion to Approve was made by Commissioner Hunthausen and seconded by Commissioner Rolfe. The motion Passed on a 3- 0 vote.

Resolution 2025-90 Approving the Bylaws for the Board of Directors of the Scratch Gravel Solid Waste District. (Audra Zacherl)

[8:08] Audra Zacherl, Public Works Assistant Director, presented a resolution approving bylaws for the Scratch Gravel Solid Waste District Board of Directors. Updates include language change from "board of directors" to "board members"; that the elected member and Health Department staff is not subject to the four -year term; and removing the requirement of having legal staff approving determination of a closed meeting. Staff recommends approval of the bylaws.

No public comment was received.

A motion to Approve was made by Commissioner Rolfe and seconded by Commissioner Hunthausen. The motion Passed on a 3- 0 vote.

Contract Between Lewis and Clark County and Northwest Technical Services, LLC. (Audra Zacherl)

[15:52] Audra Zacherl, Public Works Assistant Director, presented a contract with Northwest Technical Services, LLC for the Courthouse and Detention Center commissioning services of electrical systems for an amount not to exceed \$41,930 with work to be completed by November 30, 2025. Staff recommends approval of the contract.

No public comment was received.

A motion to Approve was made by Commissioner Hunthausen and seconded by Commissioner Rolfe. The motion Passed on a 3- 0 vote.

Resolution 2025-91 to Levy and Assess the Walter Drive Rural Improvement District No. 2015-8. (Jessica Makus)

[20:34] Jessica Makus, Special Districts Coordinator, presented a resolution to levy and assess the Walter Drive Rural Improvement District (RID) for \$220 per property per year, an increase of \$87.83. Legal notice was sent to all 23 benefiting properties and published in the Helena Independent Record. As of August 25, 2025, no written testimony has been received. Staff recommends approval of the resolution.

No public comment was received.

A motion to Approve was made by Commissioner Rolfe and seconded by Commissioner Hunthausen. The motion Passed on a 3- 0 vote.

Resolution 2025-92 to Levy and Assess the Boundary Street Contribution Rural Improvement District No. 1997-4. (Jessica Makus)

[26:25] Jessica Makus, Special Districts Coordinator, presented a resolution to levy and assess the Boundary Street Contribution Rural Improvement District (RID) for \$39.51 per property per year, an increase of \$25.76. Legal notice was sent to all 50 benefiting properties and published in the Helena Independent Record. As of August 25, 2025, no written testimony has been received. Staff recommends approval of the resolution.

[50:32] Jenny Chambers, Public Works and Planning Director, presented a grant award from Treacy Foundation for propane heater and tank installation for the Unionville School in the amount of \$10,000 with an unlimited grant period. Staff recommends approval of the grant award.

[55:13] Christal Ness, Development Services Supervisor, presented a resolution declaring the alley in block 2 of the Hotel Addition a County Road with the intention of abandonment. Staff recommends approval of the resolution.
