The Lewis and Clark Board of County Commissioners Public Meeting was held on Thursday, March 26, 2026 at 9:00 AM in Commission Chambers, Rm 330.

Action Items

Resolution 2026-15 of Intention to Create the O'Reilly Drive Rural Improvement District, No. 2026-2. (Jessica Makus)

[7:32] Jessica Makus, Special Districts Coordinator, presented a resolution of intention to create the O'Reilly Drive Rural Improvement District (RID) to assess all 49 properties to a 15 -year debt service assessment for improvements for \$320.83 annually with an ongoing maintenance assessment of \$290 annually. Each property assessment totals \$610.83 until the improvement debt is paid off. Public comment will be accepted until 4pm on May 5, 2026 with a public hearing scheduled for May 14, 2026. Staff recommend approval of the resolution.

No public comment was received.

A motion to Approve was made by Commissioner Payne and seconded by Commissioner Hunthausen. The motion Passed on a 3- 0 vote.

Resolution 2026-16 of Intention to Amend the Maynard Subdivision Rural Improvement District, No. 2005-1. (Jessica Makus)

[13:37] Jessica Makus, Special Districts Coordinator, presented a resolution of intention to amend the Maynard Subdivision Rural Improvement District (RID) to add a benefiting property that will decrease the annual maintenance assessment to \$190 annually. Public comment will be accepted until 4pm on May 5 with a public hearing scheduled for May 14, 2026. Staff recommend approval of the resolution.

No public comment was received.

A motion to Approve was made by Commissioner Hunthausen and seconded by Commissioner Payne. The motion Passed on a 3- 0 vote.

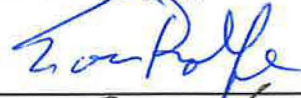

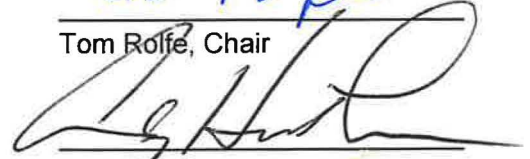
