

RESOLUTION 2016-8

RESOLUTION NAMING LEE MOUNTAIN WAY

WHEREAS, Section 76-1-102, MCA, enables local government to enact procedures which promote the health, safety and general welfare of the public; and,

WHEREAS, a coordinated system of addressing and road naming can accurately describe locations, providing for more efficient delivery of said services by reducing response times and associated costs, pursuant to Resolution 2004-16; and,

WHEREAS, the Lewis and Clark County Board of Commissioners (Commission) authorized the City-County Address Coordinator to: (1) administer a coordinated system of addressing and road naming in areas of the County, as needed; (2) charge appropriate fees for such services; and (3) maintain a dialogue with service providers to promote the implementation of the addressing and road naming system, pursuant to Resolution 2004-16; and,

WHEREAS, the City-County Address Coordinator may find it necessary to re-assign presently used addresses and road names in an effort to provide a coordinated and reliable system of identifying locations within the jurisdiction, pursuant to Resolution 2004-16; and,

WHEREAS, every road with 3 or more structures shall be given a separate, unique name, pursuant to Section 4.13.1.a, Lewis and Clark County Public Works Manual; and,

WHEREAS, on December 30, 2015, a road naming request was initiated by Mr. Jordan Alexander, Baxendale Fire District Fire Chief, to name an unnamed road beginning off of Rimini Rd; and,

WHEREAS, the unnamed road is located in the W ½ of the SW ¼ of Section 33, T9N, R5W, traveling west from Rimini Rd; and,

WHEREAS, an existing 20' private access easement is filed and recorded in the Lewis and Clark County Clerk and Recorder's Office as Document No 3177664; and,

WHEREAS, persons wishing to name an unnamed road must present a petition signed by a simple majority of abutting landowners who are in agreement with the prospective name, pursuant to Section 4.13.3.a, Lewis and Clark County Public Works Manual; and,

WHEREAS, the City-County Addressing Office sent notification letters and petition forms to adjacent property owners on January 8, 2016; and,

WHEREAS, on Wednesday, January 13, 2016, the City-County Addressing Office received a signed petition from Philip and Catherine Maynard (owners of 3 of the 4 parcels) to name the road 'Lee Mountain Way': and,



WHEREAS, on Tuesday, February 2, 2016, the Commission held a public hearing regarding the request to name the unnamed road located in the W ½ of the SW ¼ of Section 33, T9N, R5W, traveling west from Rimini Rd, 'Lee Mountain Way'; and,


WHEREAS, the Commission voted to grant approval to name the unnamed road, located in the W ½ of the SW ¼ of Section 33, T9N, R5W, beginning off of Rimini Rd and traveling west, 'Lee Mountain Way'.

NOW, THEREFORE, BE IT RESOLVED that the unnamed road, located in the W ½ of the SW ¼ of Section 33, T9N, R5W, traveling west from Rimini Rd, Lewis and Clark County, Montana, is hereby named 'Lee Mountain Way' as shown on attached Exhibit "A".


