**RESOLUTION RESCINDING RESOLUTION 1993-117 CLOSING A PORTION OF
LEWIS AND CLARK PASS IN THE GREEN CREEK AREA
TO MOTORIZED TRAFFIC**

WHEREAS, on August 10th, 1993, the Lewis and Clark County Planning Department presented Resolution 1993-117 to the Board of County Commissioners for the purpose of closing a portion of Lewis and Clark Pass Road in the Green Creek area, located in Section 17, 18, and 19, T16N, R6W, Lewis and Clark County, Montana; and

WHEREAS, a portion of Lewis and Clark Pass Road was closed to motorized traffic, but remained open for non-motorized traffic by Resolution 1993-117; and

WHEREAS, all of the affected property owners signed the petition in support of the closure to motorized travel; and,

WHEREAS, a petition was received by the Board of County Commissioners from an affected landowner to reestablish a portion of Lewis and Clark Pass Road to motorized traffic, located in Sections 17, 18, and 19, Township 16 North, Range 6 West, P.M.M., Lewis and Clark County, Montana; and

WHEREAS, a Commissioner, the County Road Supervisor, and a member for the Community Development and Planning Department conducted an inspection of the portion of road to be reestablished for motorized traffic; and

WHEREAS, public notice of a hearing on the proposed reestablishment of motorized travel was published on October 18 and October 25, 2015; and two signs were posted giving similar public notice in the vicinity; and

WHEREAS, comments were solicited from pertinent private parties and public agencies and no adverse effects resulting from the motorized vehicle reestablishment were identified; and

WHEREAS, public hearings were held on November 3, 12, 15, 2015, and November 17, 2016; and

WHEREAS, at the public hearing held on November 17, 2016, the Board of County Commissioners determined that the public interest would be more adequately served by the above-requested reestablishment of motorized traffic; and

WHEREAS, the reestablishment of Lewis and Clark Pass Road for motorized traffic does not address or alter the maintenance provisions thereof; and;


WHEREAS, the Condition of Approval for the installation of signs has been completed.



NOW, THEREFORE LET IT BE RESOLVED, by the Lewis and Clark County Board of County Commissioners that it does hereby rescind Resolution 1993-117, and declares Lewis and Clark Pass Road reestablished for motorized traffic in Sections 17, 18, and 19, Township 16 North, Range 6 West, P.M.M., Lewis and Clark County, Montana, as shown on the attached Exhibit A.



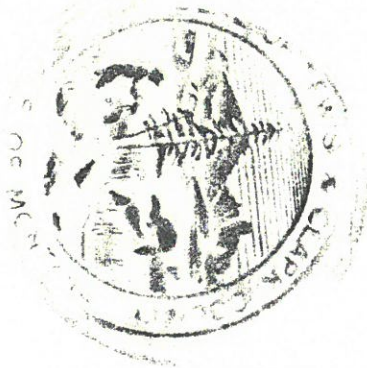
