

RESOLUTION 2018-66

RESOLUTION NAMING TATANKA LN

WHEREAS, Section 76-1-102, MCA, enables local government to enact procedures which promote the health, safety and general welfare of the public; and,

WHEREAS, a coordinated system of addressing and road naming can accurately describe locations, providing for more efficient delivery of services by reducing response times and associated costs; and,

WHEREAS, the Lewis and Clark County Board of Commissioners (Commission) authorized the City-County Address Coordinator to: (1) administer a coordinated system of addressing and road naming in areas of the County, as needed; (2) charge appropriate fees for such services; and (3) maintain a dialogue with service providers to promote the implementation of the addressing and road naming system, pursuant to Resolution 2004-16; and,

WHEREAS, the City-County Address Coordinator may find it necessary to re-assign presently used addresses and road names in an effort to provide a coordinated and reliable system of identifying locations within the jurisdiction; and,

WHEREAS, every road with 3 or more structures shall be given a separate, unique name, pursuant to Section 4.13.1.a, Lewis and Clark County Public Works Manual; and,

WHEREAS, in June, 2018, a road re-naming request was initiated by Mr. Josh Dalzell to re-name Squeeker Ln; and,

WHEREAS, Squeeker Ln is located in the NE ¼ of Section 6, T11N, R04W, traveling north/northeast from Racehorse Lp approximately 1600'; and,

WHEREAS, an existing 30' access easement is filed and recorded in the Lewis and Clark County Clerk and Recorder's Office as Document No. 436752 (Certificate of Survey); and,

WHEREAS, an existing 30' access and utility easement is filed and recorded in the Lewis and Clark County Clerk and Recorder's Office as Document No. 3163520 (Certificate of Survey); and,

WHEREAS, persons wishing to name an already-named road must present a petition signed by a simple majority of abutting landowners who are in agreement with the prospective name, pursuant to Section 4.13.3.a, Lewis and Clark County Public Works Manual; and,

WHEREAS, on Monday, July 16, 2018, the City-County Addressing Office received a signed petition to name the road 'Tatanka Ln'; and,

WHEREAS, on Tuesday, July 31, 2018, the Commission held a public hearing regarding the request to re-name Squeeker Ln located in the NE ¼ of Section 6, T11N, R04W, traveling north/northeast from Racehorse Lp approximately 1600'; and,

WHEREAS, the Commission voted to grant approval to re-name Squeeker Ln to Tatanka Ln, located in the NE ¼ of Section 6, T11N, R04W, traveling north/northeast from Racehorse Lp



approximately 1600'; and,

NOW, THEREFORE, BE IT RESOLVED that the road located in the NE ¼ of Section 6, T11N, R04W, traveling north/northeast from Racehorse Lp approximately 1600, Lewis and Clark County, Montana, is hereby named 'Tatanka Ln' as shown on attached Exhibit "A".
