



RESOLUTION 2021 – 93

**A RESOLUTION OF INTENTION TO ESTABLISH THE LEWIS AND CLARK COUNTY
LANDFILL FEE RATES BEGINNING NOVEMBER 5, 2021**

WHEREAS, Section 7-13-232 (1) and (3) (a) (i), MCA, states the Board may establish by resolution, rates for service charges; and

WHEREAS, the Lewis and Clark County Landfill serves the Scratch Gravel Solid Waste District, the Marysville Solid Waste Subservice Area, and the City of Helena; and

WHEREAS, the Scratch Gravel Solid Waste District Board and the Board of County Commissioners in Resolution 2020-43 established the current landfill fees.

WHEREAS, the Board of Directors for the Scratch Gravel Solid Waste District voted on September 23, 2021 and recommended changes in the landfill fees to maintain and operate the County landfill, purchase equipment, make debt service payments, and to maintain adequate cash reserves.

WHEREAS, any comments or protests to the proposed fee changes shall be addressed in writing to the Lewis and Clark County Clerk and Recorder's Office, 316 N. Park Avenue, Helena, MT 59623, prior to November 3, 2021 at 4:00 p.m. local time; and

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Lewis and Clark County that it does hereby establish its intention to set the following landfill fee rates to be effective on November 5, 2021;

*Municipal Solid Waste Tipping Fee – Class II	\$26.00 per ton
Special Loads Solid Waste Tipping Fee – Class II	
Liquid Waste	\$ 7.00 per ton
Compostable Material	\$10.00 per ton
Dead Animal	\$25.00 per animal
*Asbestos, $\frac{1}{2}$ ton minimum	<u>\$60.00 per ton</u>
^Contaminated Soil	\$10.00 - \$30.00 per ton
Wastewater Sludge and Bar Screenings	\$50.00 per ton
Mattress Fee, each	\$10.00 plus tipping
Box Spring Fee , each	\$10.00 plus tipping
Passenger/Light Truck Tire, each (on rims)	\$10.00 plus tipping
Passenger/Light Truck Tire, each (off rims)	\$ 5.00 plus tipping
Truck Tires, each (on rims)	\$25.00 plus tipping
Truck Tires, each (off rims)	\$15.00 plus tipping
*Construction and Demolition Waste – Class IV	
Acceptable Materials	\$23.00 per ton
Unacceptable Materials	\$50.00 per ton
Violation Fee	\$75.00
Minimum Fee 0-500 pounds	\$ 5.75
Accounts Receivable Reactivation Fee	\$25.00
Covered Loads Violation Fee – 2 nd Offense	\$50.00

* MSW Class II, Construction and Demolition Class IV, and Asbestos rates may be adjusted based on operational assessment to include waste volumes, contract terms and fiscal impacts.

^ Contaminated soil tipping fee will be based on analytical results, volumes, contract terms and fiscal impacts.

^* \$60.00 per ton based on 1,300 pounds per cubic yard

BE IT FURTHER RESOLVED by the Board of County Commissioners of Lewis and Clark County that a public hearing to hear all comments or protests on the landfill fees will be held on November 4, 2021 at 9:00 a.m. in Room 330 of the City-County Building, 316 N. Park Avenue, Helena, Montana.
