RESOLUTION TO DISSOLVE THE TILLY COURT RURAL IMPROVEMENT DISTRICT, NO. 2011-2

WHEREAS, the Lewis and Clark County Board of Commissioners may dissolve a Rural Improvement District (RID) whenever dissolution is considered to be in the best interest of the county and the inhabitants of the district; the purpose for creating the district has been fulfilled; or the work and improvements engaged in under the authority of the district have been completed or otherwise secured, Section 7-12-2124, MCA; and

WHEREAS, the boundary of the district to be dissolved is shown on Exhibit "A"; and

WHEREAS, a request was received from 100% of property owners of the district to dissolve the Tilly Court RID, No. 2011-2, shown on Exhibit "B"; and

WHEREAS, it was determined that there was not sufficient protest to bar proceedings as per Section 7-12-2124, MCA.

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners does hereby dissolve the Tilly Court Rural Improvement District, No. 2011-2.

BE IT FURTHER RESOLVED that any assets remaining after all debts and obligations of the district have been paid must be deposited into the general fund of Lewis and Clark County.


